- c) Community groups and agencies Allen reported on Friends of Butte Creek recent creekside restoration activities utilizing subcontracted funds from Fire Safe Council's RAC grant. With Kimberly's help, project involved moved 10-12 large fire-killed logs, emplacing them into the bank, and then using them as nurse logs to plant many individuals of 6 different kinds of shrubs. These shrubs are on a drip timer and show 95% establishment success so far.
